MAY 3, 2016 MEETING OVERVIEW

A Regular Meeting of the Board of Education came to order at 6:04pm at the call of Chair Tom Koehler in the Board Auditorium of the Blanchard Education Service Center, 501 N. Dixon St, Portland, Oregon.

Attendance:

Recognitions

- The Board recognized the Lincoln Constitution Team who won first place in the *National We the People* Competition. This marked the fifth consecutive year that a PPS team had taken the national title, with now having won a total of eight national titles.
- The Board recognized teachers and school administrators, announcing that May 2nd through 16th was Teacher and School Administrator Appreciation Week.
- The Board recognized the nearly 800 employees who were celebrating 5-year incremental service milestones.

Student Comment

Students from Roosevelt High School requested that race and social justice classes be added to PPS instruction.

Public Comment:

Lori Lyons-Lachman: There is disparity at Beach School; a fourth grade class was facing its fourth month of substitute teachers, and the students are losing trust in the adults that are teaching them. Each student should be guaranteed a hardship transfer.

Jackie Haddon: The Maplewood Community still has some outstanding questions regarding the boundary changes on the west side. Will grandfathering continue to extend to young siblings? When will parents be informed of new bus stops?

Nicole Iroz-Elardo and Scholle McFarland: PPS was not meeting its legal obligation under Division 22 regarding Talented and Gifted (TAG) students. TAG students were not being educated at their rate of learning. The proposed TAG budget was insufficient. Recommendations were presented to the Board.

Anton Bilbaeno: Asked if the current Board meeting format was an effective way to hear from the community. How do ideas live on and stay relevant? How does the Board know what the most important idea was in the community? His goal was to help answer those questions with an on-line platform.
